do hereby give my consent to the participation of my child in the International Running Competition Almaty Marathon 2021 (distance: _____) arranged by **“Courage to be the First” Corporate Fund** (hereinafter – “Organizer”), to be held on April 11, 2021 in Almaty (hereinafter – “Competition”).

I hereby:

1) acknowledge that I and my child have read and understood the Competition Regulations available at the Organizer’s website: <https://www.almaty-marathon.kz/en/> (hereinafter – “Website”), and we absolutely agree to follow them;

2) acknowledge that my child has had a medical check by a doctor and has no any counter-indications to participate in the Competition and undertake that I don’t allow my child to participate in the Competition, if my child’s health deteriorates by/on the Competition date;

3) acknowledge and agree that if any symptoms and/or signs of the Covid-19 viral disease are revealed in my child/any representatives from our inner circle, or if my child/any representatives from our inner circle obtain a positive test result, I undertake not to allow my child to participate in the Almaty Marathon 2021 (to receive the Participant’s starter kit and to take part in the Almaty Marathon 2021);

4) undertake to bring to the knowledge of my child the importance of observing the measures taken by the Organizer to prevent the spread of the coronavirus disease, and make sure that my child observes those. I also acknowledge that my child has read and understood the Regulations to Combat the Spread of Covid-19 at a Sports Event posted by the Organizer on the Website;

5) am aware of and understand the complexity of the Competition and acknowledge that my child has sufficient technical knowledge and skills in running the declared distance of the Competition and that he/she is physically and mentally well-prepared for participation in the Competition;

6) am aware of the fact that my child's participation in the Competition may result in the adverse health consequences, and I shall be fully responsible for my child's safety and health;

5) acknowledge that the Organizer shall not be liable for my child's death or injury as a Participant of the Competition, loss or damage to our personal belongings, as well as any physical harm to my child as a Participant of the Competition, occurred during the Competition, and I shall voluntarily and knowingly refuse from any material and other claims and demands towards the Organizer (its employees) and sponsors of the Competition. This refusal from the claims shall apply to my potential successors and caregivers and shall be valid before, during and after the Competition;

6) acknowledge that during the Competition I and my child will, never and under no circumstances, intentionally create situations, which may cause damage to other participants, the Organizer and sponsors of the Competition, unauthorized persons, as well as their property;

7) acknowledge that for the compliance by the Organizer with the Law of the Republic of Kazakhstan "On Personal Data and Their Protection", for my child's registration for the participation in the Competition:

- I agree to provide the documents supporting the information in this Acknowledgement (my and my child) upon the Organizing Committee's request;

- by completing the Registration Form for my child's participation in the Competition at the Organizer's Website and providing the Organizer with the documents supporting the information in this Acknowledgement, I give my consent to the collection, processing, use and storage of my personal data and my child's personal data by the Organizer of the Competition, which will be provided to the Organizer only for ensuring my child's registration for the participation in the Competition;

8) pursuant to Article 145 of the Civil Code of the Republic of Kazakhstan, taking into consideration the requirements of Paragraph 8 of Article 15 of the Civil Code of the Republic of Kazakhstan, for the popularization of the Almaty Marathon sports events, as well as the Organizer's activities, I give my consent to:

- the video and photo shooting of my image and my child's image (photo and/or video), of the process of my participation and my child's participation in the Competition to be made by the Organizer and/or third parties acting on behalf and/or to the benefit of the Organizer;

- use my name and my child's name, publish, reproduce and distribute my image and my child's image and/or other audio, video, photo materials resulting from the Competition by any ways and means without any limitations as to time and area of application. I give this consent on a free-of-charge basis for the indefinite period.
