**I hereby:**

- 1) acknowledge that I have read and understood the Competition Regulations available at the Organizer’s website: <https://www.almaty-marathon.kz/> (hereinafter – “Website”), and I absolutely agree to follow them;
- 2) acknowledge that I have had a medical check and have no counter-indications to participate in the Competition and shall not participate in the Competition, if my health deteriorates by/on the Competition date;
- 3) am aware of and understand the complexity of the Competition and acknowledge that I have sufficient technical knowledge and skills in running the declared distance of the Competition and that I am physically and mentally well-prepared for participation in the Competition;
- 4) am aware of the fact that my participation in the Competition may result in the adverse health consequences, and I shall be solely responsible for my own safety and health;
- 5) I hereby confirm, agree, and declare that the Organizer shall bear no responsibility in the event of my death, injury, and/or any other damage to my health as a participant of the Competition, as well as for the loss or damage of my personal property, or for any physical condition impairments (actual or potential deterioration of health) occurring during the Competition.

In this regard, I voluntarily and knowingly waive any material or other claims and demands against the Organizer (its employees) and the sponsors of the Competition. This waiver of claims is unconditional and final, and it extends to myself, my heirs, guardians, trustees, legal representatives, and successors. It remains in full force before, during, and after the Competition, including any preparatory activities, as well as any consequences arising after the event, regardless of any fault on the part of the Organizer (its employees) or the sponsors;

6) acknowledge that during the Competition I will, never and under no circumstances, intentionally create situations, which may cause damage in any form to other participants, the Organizer and sponsors of the Competition, unauthorized persons, as well as their property, and undertake to compensate for the damage caused;

7) acknowledge that for the compliance by the Organizer with the Law of the Republic of

Kazakhstan “On Personal Data and Their Protection”, for my registration for the participation in the Competition:

- I agree to provide the documents supporting the information in this Acknowledgement upon the Organizing Committee’s request, and give my consent to collect, process, use and store personal data;
- by completing the Registration Form for participation in the Competition at the Organizer’s Website and providing the Organizer with the documents supporting the information in this Acknowledgement, I give my consent to the collection, processing, use and storage of my personal data by the Organizer of the Competition, which will be provided to the Organizer only for ensuring my registration for the participation in the Competition;

8) pursuant to Article 145 of the Civil Code of the Republic of Kazakhstan, taking into consideration the requirements of Paragraph 8 of Article 15 of the Civil Code of the Republic of Kazakhstan, for the popularization of “Courage to be the First” CF’s sports events, as well as the Organizer’s activities, I give my consent to:

- the video and photo shooting of my image (photo and/or video), of the process of my participation in the Competition to be made by the Organizer and/or third parties acting on behalf and/or to the benefit of the Organizer;
  - I hereby grant the Organizer the right to use my name and any image of me obtained during the Competition, as well as the right to publish, reproduce, distribute, and otherwise use my image and/or any other audio, video, or photographic materials obtained in the course of the Competition, by any means and in any form, without limitation in time or territory.

This includes placement on the Internet, on the Organizer’s official resources, publication in mass media, and use for advertising, informational, social, or other purposes aimed at promoting sports and charitable initiatives.

9) I hereby provide the Organizer with my prior and unconditional consent and authorization to act at their discretion on my behalf for the protection of my rights and legitimate interests in the event of unlawful use of my image by third parties, including:

- sending claims and demands for cessation of violations;
- filing applications with courts and other authorized bodies;
- requesting the removal of illegal content and blocking unlawfully posted images and materials (publications);
- claiming compensation, including compensation for moral damages.

The Organizer is not obliged to undertake these measures in every case and independently determines the necessity and scope of their application. The Competition Participant who has granted this consent shall not be entitled to make claims against the Organizer should the latter choose not to take such measures.

The consent provided under this clause constitutes my explicit expression of will, has an independent legal effect under the civil legislation of the Republic of Kazakhstan, and is granted by me on a gratuitous basis for an indefinite period.

10) when signing this Acknowledgement, I confirm that I am not under the influence of drugs, intoxicants or alcohol, my health state allows me to exercise and protect my rights and execute duties, I do not suffer from any diseases that can hinder my understanding of the document I signed, and also acknowledge that I am not under the influence of deceit, fraud, violence, threat, bad faith collusion or concurrence of difficult circumstances.

11) I confirm, declare, and guarantee that this Acknowledgement is written by me, and in the case that the Acknowledgement is not signed by me in person, the Organizer shall not be held liable hereunder;

12) I confirm, declare, and guarantee that all risks associated with possible mistakes or inaccuracies are fully borne by me as a legally capable person;

13) I acknowledge, confirm and guarantee that signing of the Acknowledgement by third parties, as well as provision of inaccurate personal data may serve as grounds for refusal of admission to

the Competition without refund of the registration fee.
